Residential Zones Standing Advisory Committee – Melbourne Draft Amendment C179

Thank you for your submission regarding the Residential Zones Standing Advisory Committee – Melbourne Draft Amendment C179.

The Minister for Planning, the Hon Matthew Guy, has appointed an Advisory Committee pursuant to Section 151 of the *Planning and Environment Act 1987*, to report on proposals to rezone land to the new Neighbourhood Residential Zone, General Residential Zone and Residential Growth Zone. In the case of draft Amendment C179, Council proposes to apply the Neighbourhood Residential Zone and Residential Growth Zone.

This matter will be heard by Mr Michael Kirsch (Chair) and Mr Peter Newman (Member).

The role of the Advisory Committee is to:

- Give submitters an opportunity to be heard in an independent forum in an informal, non-judicial manner. An Advisory Committee is not a court of law.
- Give independent advice to the Minister for Planning as outlined in the Terms of Reference.

Please note that all submissions and information provided at the Hearing in respect of the draft Amendment will be **treated as public documents**. Further details are provided in the attached *Privacy Collection Notice*.

Important Notes

- 1. The Committee notes that some submissions received relate to the application of the General Residential Zone (GRZ). The Committee is only considering matters relating to the Neighbourhood Residential Zone (NRZ) and Residential Growth Zone (RGZ) as proposed in the draft Amendment. The General Residential Zone (GRZ) was introduced into the Melbourne Planning Scheme on 13 June 2014. Submitters wishing to withdraw from this process on this basis should do so in writing to Ms Jessica Cutting.
- 2. Please note that verbal and written submissions at the Hearing must relate to the specific matters raised in the original submission. This allows the Council submission to address the issues raised in its submission to the Committee. The Advisory Committee cannot accept the introduction of new issues at the Hearing.
