### PROPOSED DEFINITION OF A SIGNIFICANT HERITAGE PLACE

A significant heritage place is individually important at state or local level, and a heritage place in its own right.

*It is of historic, aesthetic, scientific, social or spiritual significance to the municipality.* 

It is typically externally intact and/or has notable features associated with the place type, use, period, method of construction, siting or setting.

When located in a heritage precinct a significant heritage place can make an important contribution to the precinct.

#### PROPOSED DEFINITION OF A CONTRIBUTORY PLACE

A contributory heritage place is important for its contribution to a precinct.

*It is of historic, aesthetic, scientific, social or spiritual significance to the precinct.* 

It may be a representative example of a place type, period or style, and/or combines with other visually or stylistically related places to demonstrate the historic development of a precinct.

Contributory places are typically externally intact but may have visible change which do not detract from the contribution to the precinct.
