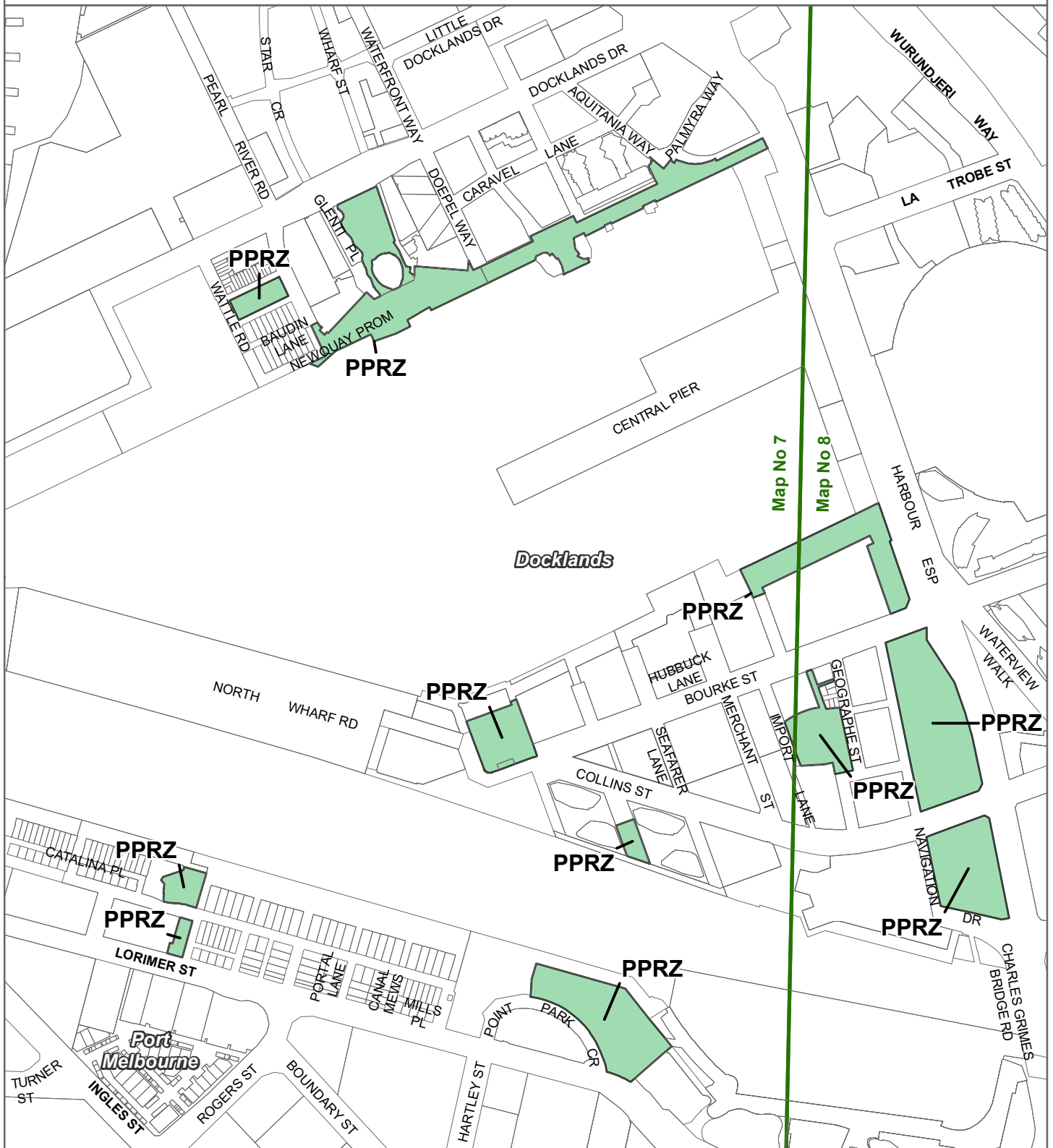

- Local Government Area



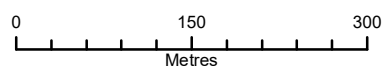

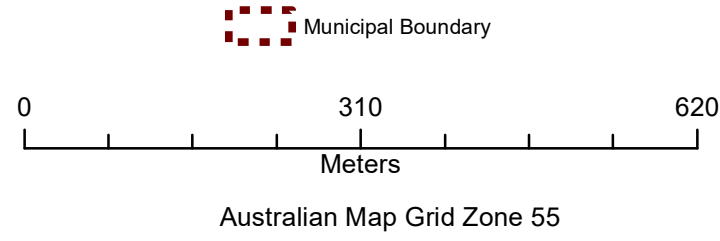
INDEX TO ADJOINING SCHEME MAPS

PPRZ - Public Park and Recreation Zone



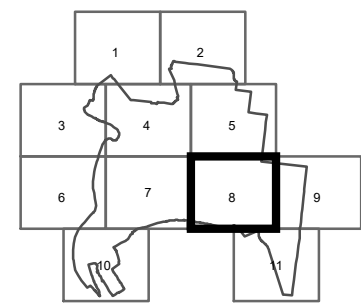

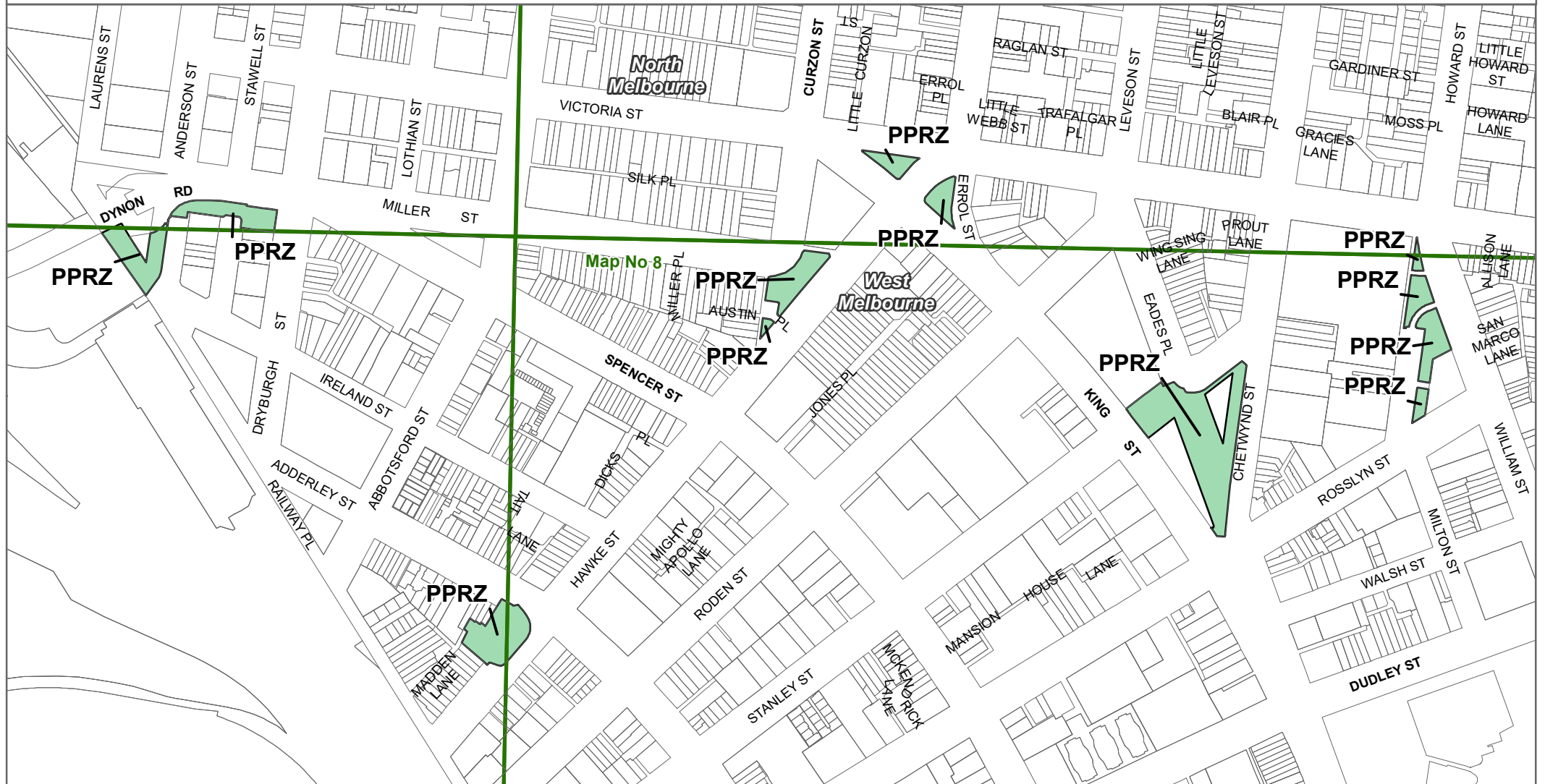


INDEX TO ADJOINING SCHEME MAPS

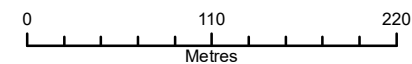

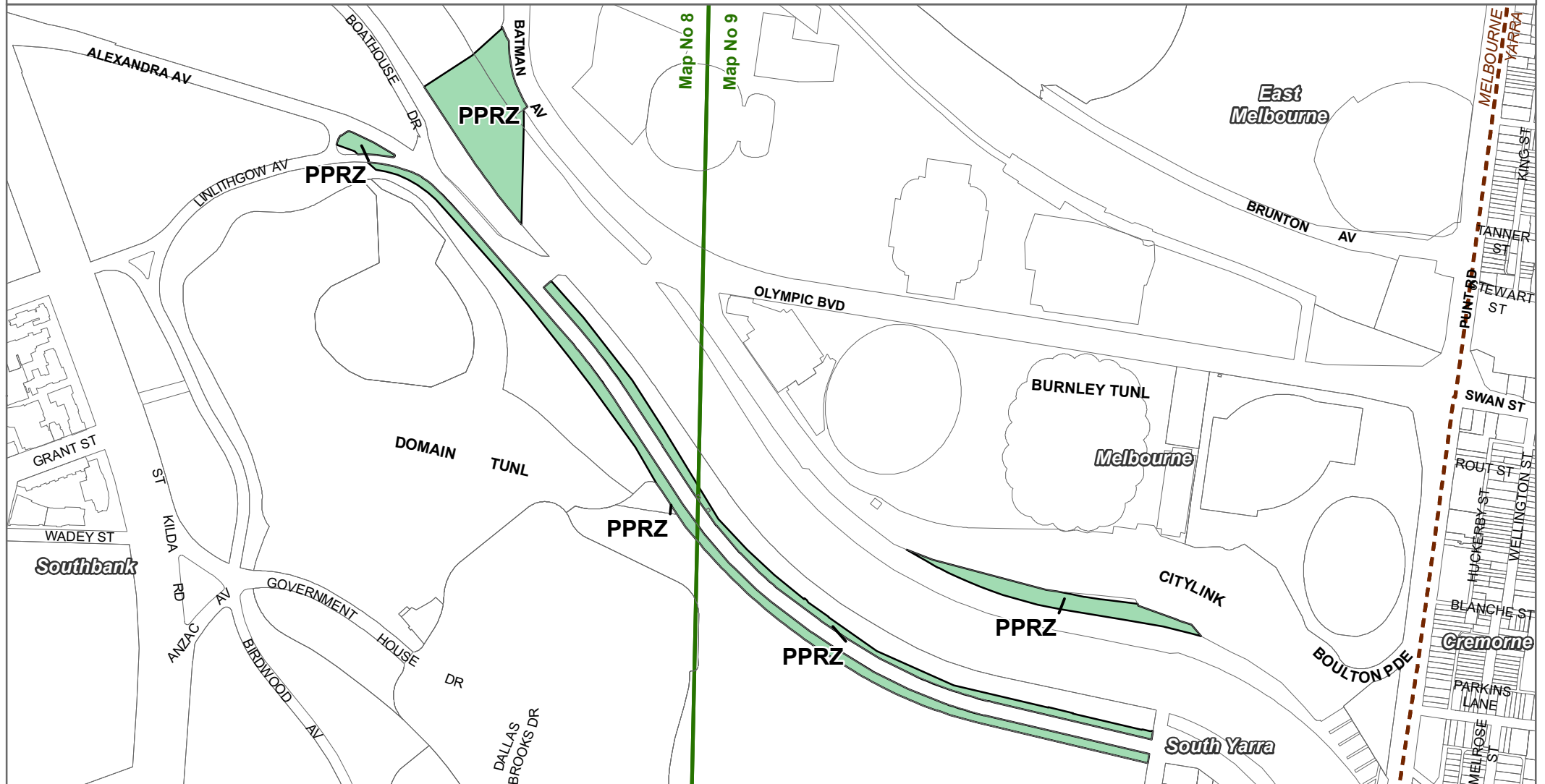

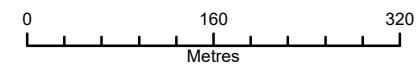
