2018	Lovell Chen commenced the Carlton Heritage Review on behalf of the City of Melbourne.
10 JULY 2020	Amendment C258 was gazetted and introduced a new heritage category system. The category for Punt Road Oval was deleted in error.
2021	The Punt Road Oval Heritage Review was prepared.
NOVEMBER 2021	The Carlton Heritage Review is finalised.
11 NOVEMBER 2021	Prescribed Amendment C414 was gazetted to correct the error made through Amendment C258 and restore the former heritage grading for Punt Road Oval.
16 NOVEMBER 2021	<ul> <li>Future Melbourne Committee resolves to, among other things:</li> <li>Seek authorisation from the Minister for Planning for Amendment C405</li> <li>Request the Minister prepare and approve interim heritage controls through Amendment C404.</li> </ul>

23 JUNE 2022	In response to submissions, and heritage advice, proposed changes to the heritage gradings of a limited number of properties is sought to be

	advanced. Informal notification is undertaken to affected properties, as well as to the Department of Transport in respect of Punt Road Oval.
30 JUNE 2022	Amendment C421 was gazetted to apply a SCO and Incorporated Document to Punt Road Oval to facilitate the redevelopment project.
7 JULY 2022	<ul><li>Amendment C396 was gazetted to finalise the grading conversion of the outstanding places from Amendment C258.</li><li>As the conversion for Punt Road Oval was omitted in error, the gazetted version of C396 retained the Part B Heritage Places Inventory for this place</li></ul>

22 JULY 2022	The Heritage Council Victoria advertised the Executive Director's recommendation that the John Curtin Hotel should be included in the Victorian Heritage Register.
28 JULY 2022	One (1) further submission from the Department of Transport is received in response to the additional notification.
13 AUGUST 2022	A late submission (Submission #10) is made directly to the Future Melbourne Committee.

9 SEPTEMBER 2022	Directions hearing for the Amendment is held. Council formally refers the two late submissions #11 and #12.
